### Maintenance

- Place the unit on a level surface away from sources of direct sunlight or excessive heat.



- Connect the micro-USB plug to the audio/charge input jack on the speaker.
- Connect the stereo 3.5mm audio plug to the headphone jack or line-out of any audio device.
- . Slide the Power Switch of the speaker to the ON position. The white power light will come on.
- Press play on your audio device and adjust its volume to listen to audio.
- If you wish to "daisychain" multiple mini speakers together (up to 5 units), connect the 3.5mm audio plug to the Line Out Jack on a mini speaker that is already connected to an audio source (see above) and the micro-USB plug to the audio input jack on
- another mini speaker. Turn on second speaker by sliding Power Switch to ON. • When you are done listening, turn the speaker OFF to conserve battery charge.
